





## What's Driving Interest in Pellet Manufacturing/Heating, and Policymaker Attention?

- High energy costs
- Fossil energy price volatility, e.g. propane, natural gas
- "Local" movement e.g. food, why not fuel?
- <u>Policy attention on rural America</u>, income gap
- Increased understanding of vital necessity of <u>good</u> <u>markets for low grade wood, viable forest ownership</u>
- <u>Reducing fuel loads</u> in regions of high forest fire risk
- GHG emission reduction strategies could cut both ways
- E-NGO attention on export pellet growth (generating scrutiny on domestic pellet manufacturing)

### Some Examples

- Biomass thermal in state energy plans MA, NH, NY, VT
- Biomass thermal in state RPS programs NH, MA, OR; RI, NY considering
- State grant programs NH, MA, ME, VT, NY, PA
- Rebates for pellet appliances NH, ME, MA, VT, NY, MD
- Tax credits OR, WV
- Leverage of private capital USEFC "T-RECs Enterprise Fund"

#### Oregon Woodsmoke Working Group

- Legislation mandating statewide strategy to reduce wood smoke pollution
- Changeout programs: shift to pellet heating, education/outreach
- State building code: mandate upgrade of wood heat system if renovating
- "Bounty program"



#### Massachusetts Thermal APS Rulemaking


- Push by anti-pellet and chip heating E-NGOs to make regulations so onerous no one can qualify
- Same groups that stopped biomass electric generation in MA in 2011 (Manomet Study)
- Particulate emissions, GHG emission reductions, sustainability of feedstocks
- Stay tuned implications to modern wood heating everywhere



# **Maine Biomass Energy Task Force**

- Four biomass power plants threatened with closure in last year
- Maine legislature formed Commission to Study the Economic, Environmental and Energy
- Includes specific reference to <u>biomass thermal</u>
- Opportunity to enhance support for commercial scale pellet heating through thermal RPS and/or grants and rebates
